**TENDER NOTICE AND INVITATION TO TENDER**

Tenders are hereby invited from suitably qualified, experienced and skilled Civil Engineering Contractors with a minimum CIDB grade of 7 CE (or higher) for the construction of the Upgrade of Bathurst Bulk Sewer: Wastewater Treatment Works.

The scope of work for this project includes the construction of the components listed below.

Scope of Work – Upgrade of WWTW (1 050 kℓ Capacity)	
Scope Components	Description
Site	Site establishment and site clearance.
Earthworks	Bulk excavation for platform and structures. Restricted excavation for minor structures.
Inlet alterations	Partial demolition, construction of new canals, and mechanical installations.
Anaerobic Ponds	Construct new ponds and ancillaries (pipework, subsoil drainage, sumps, etc.)
Aerobic pond	Construct new pond and ancillaries (HDPE liners, pipework, subsoil drainage, etc.)
Settling pond	Construct new pond and ancillaries (pipework, subsoil drainage, sumps, etc.)
Drying beds	Construct new drying beds and ancillaries (HDPE liners, pipework, sumps, etc.)
Refurbish existing ponds	Emptying existing ponds, removing sludge, and repairing as needed.
New building (pump, chlorination, guard, office, and lab)	Construct new building and install ancillaries (plumbing, furniture, pipework, mechanical, and electrical.)
Pipelines	Install pipelines, ancillary structures, and fittings for potable water, sewer, de-sludging, aeration, chlorination, recycling, and recovery.
Access and internal roads	Upgrade the existing access road and construct internal roads.
Fencing	Demolition, refurbishment, supply and erection of perimeter fencing and gates.
Canals	Construction of required canals.
Mechanical works	Supply, installation, and commissioning of mechanical works.
Electrical works	Supply, installation, and commissioning of Electrical works.
ESKOM connection	Construct a new medium voltage overhead line and step-down transformer to connect WWTW.

The bid evaluation process will be based on below steps, and the qualified tenderers will be subject to negotiations of the most acceptable rate as outlined in the Standard for Uniformity in Engineering and Construction Works Contracts as contained in the Government Gazette No 42622 of August 2019.

Where applicable, negotiations will only be conducted with the preferred tenderer in accordance with the Ndlambe LM SCM policy, Clause C.3.13 of the Standard for Uniformity in Engineering and Construction Works Contracts (Government Gazette No. 42622 of August 2019), as guided by CIDB Best Practice Guideline A6.
