5. Bids that are late will not be considered, whilst the lowest or only quotation will not necessarily be accepted.

## SPECIFICATIONS

### **PROVISION OF ADVERTISING SERVICES**

#### **Pre-qualification Criteria**

Bidders must demonstrate that the newspaper/publication meets all of the following conditions:

1. Audit-verified circulation:
  - 1.1. The publication must have circulation independently verified by the Audit Bureau of Circulations (ABC) (<https://abc.org.za>) or equivalent recognised industry body. Proof of current certification must be submitted with the quotation.
2. Ndlambe statutory footprint:
  - 2.1. The publication must have established weekly distribution and readership within the Ndlambe Local Municipality, specifically covering Port Alfred, Kenton-on-Sea, Marselle, Bushman's River, Alexandria and Kleinemonde.
3. Publication frequency
  - 3.1. The publication must be published at minimum once per week to ensure compliance with statutory notice periods applicable under the Local Government: Municipal Finance Management Act 56 of 2003, the Municipal Systems Act 32 of 2000, and the Supply Chain Management Regulations.

#### **Scope of Work**

The appointed service provider will be responsible for the placement of all municipal public notices, tender advertisements, budget notices, public participation notices, by-law notices, and other official statutory and non-statutory communications as and when required by the Municipality.

The scope of work includes but is not limited to:

- (a) Receipt of advertisement copy from the SCM Unit or Communications Office;
- (b) Typesetting, layout, and formatting of the notice in accordance with the Municipality's requirements and any applicable statutory format requirements, where the Municipality does not supply camera-ready artwork;

#### 3.4 Turnaround commitment

The bidder must commit to same-week publication where copy is submitted by the edition's copy deadline. The copy submission deadline per edition must be stated in the bid.
